School-based Speech Therapy Service

The school has received subsidy from the Education Bureau for implementation of school-based speech therapy service. The service will be provided on the school campus by a speech therapist 1 day per month. Students in need will receive appropriate therapy to facilitate more effective learning during lessons. The scope of the school-based speech therapy service includes:

1. Speech and language assessment for students suspected of having speech and language impairment;
2. Therapy and follow-up for students with speech and language impairment;
3. Consultation and training for teachers and parents;
4. Design and organization of whole-school activities with specific themes to enhance students' speech and language abilities.

Students in need will be referred by teachers to receive the service. It will be provided to these students until a certain extent of improvement is seen in their speech and language abilities, or until they discontinue their studies at the school. The school will provide relevant information of these students to the school-based speech therapist, for the therapist's reference, to facilitate accurate speech and language assessment. The school will also provide these students' personal information and information about their speech and language impairment to the Education Bureau. Such information will be stored in the Education Bureau's Special Education Management Information System (SEMIS), and will be updated as needed, for education purposes.
